Terms and Conditions

From the Constitution of Samajam, please take note of the following pertaining to Junior MEMBERSHIP:

***Junior membership** shall be afforded to children of ordinary members provided they are under 21 years of age.

Applications for membership shall be made on the prescribed form in writing.

Applications for membership shall be approved by the Management Committee (MC), The MC shall have powers to reject any application without assigning any reason therefore and it's decision shall be final.

Junior members shall have unrestricted right, subject to the Rules of the Samajam, to take part in all its activities, to enjoy all its amenities.

ENTRANCE FEE & SUBSCRIPTION

Subscription for junior membership shall be \$1/- per annum. Such members are not required to pay an entrance fee. A Junior member may be promoted to an Ordinary member (as a volunteer for once) until he reaches the age of 21 (Upon reaching 21 he must have served at least for 3 years). This is solely at the discretion of the MC. Once promoted, the member will be required to pay the annual fees for that category of membership he/she is promoted to.

RESIGNATION

Any member who wishes to resign shall notify the Hon. Secretary of this intention in writing and shall at the same time pay up any arrears of subscription or other dues. He shall not cease to be a member until his resignation is accepted by the Management Committee.

A member who resigns shall not be eligible to re-apply for membership for six months from the date of acceptance of his resignation by the Management Committee.

EXPULSION

A member whose conduct is found by the Management Committee to be prejudicial to the interests of the Samajam, shall be informed accordingly and be requested by the Committee to resign or be asked to explain in writing why he should not be expelled. If he does not do so within fourteen days of such request or if his explanation is not satisfactory to the Committee, he shall be expelled at the discretion of MC.

*Every member shall notify the Hon..Secretary of changes in his address. All communications to a member shall be deemed to have been served if dispatched to the address last notified by him.
